1: Job Purpose

- 1.1 We are seeking enthusiastic and passionate Maths teachers with high level technical abilities to contribute to innovating Maths delivery, and enable the College to become a centre of excellence. Reporting to the Quality Improvement & Education Managers you will be responsible for implementing teaching strategies to enable students to develop skills in Maths and achieve high grades.
- 1.2 The successful applicant will be passionate about Maths and have the ability to inspire interest and curiosity in students and enable them to develop either basic, intermediate or advanced skills in using mathematical calculations. They will inspire students to appreciate that maths is a part of every day life and practical maths skills will be essential to have in their chosen careers and work environment. You will be responsible for teaching Maths to at least GCSE Level, A Level and potential Degree level and act as a role model and work with other teaching staff to develop their technical teaching skills.
- 1.3 Our students join us from a variety of education areas having had varying education experiences. These include, secondary education, home educated or through adult education where they have not achieved the basic level of a Grade C or Grade 4/5 Maths as a standard qualification. Some require Maths qualifications to progress to the next level of education whilst others require the qualification to enable them to progress in their work life or chosen career. Some may have no interest or have lost interest in the subject, but need the qualification. As part of their study programmes, it is essential they undertake their Maths qualifications and are seeking your expertise to help them to achieve their goals and career aspirations.

2.0 Key Responsibilities

- a) To implement teaching strategies to enable students to develop technical skills in Maths and enable them to achieve higher grades in Maths qualifications.
- b) To work collaboratively with all staff involved in the delivery of Maths curriculum, at all levels including, entry level, GCSE, A Level and degree level.
- c) To deliver high quality learning experience for students according to their educational needs, meeting internal and external quality standards.
- d) Lessons to be planned and delivered using a variety of delivery methods which will stimulate learning and ensure progress appropriate to students needs and demands of the curriculum.

- e) Monitor and track students progress and achievement effectively and ensure it is inclusive to accommodate the needs of all students, and they are supported to achieve their full potential.
- f) Identify learners who may be struggling and implement strategies to enable them to continue to improve their Maths technical skills.
- g) Set clear expectations of our students, their behaviour and conduct and deal with any issues arising in a timely manner.
- h) Responsible for student attainment, retention and success through engaging maths lessons which embed the relevance to careers / jobs and general life skills.
- i) A focus on the continual improvement of teaching, learning and assessment and demonstrate high standards in your own teaching practice, acting as a role model for other academic staff.
- j) Develop and deliver CPD sessions to colleagues to enable them to develop their own high level technical skills in delivering Maths curriculum to our students.
- k) Take appropriate action to comply with internal quality assurance processes / regulations (Ofsted) and ensure all Awarding Body regulations are adhered to ensure external funding body requirements are met.
- l) Ensure the safeguarding, health, safety and welfare of our students and staff at all aspects of your role.
- m) Manage learning environments to ensure they are suitable and promote interest and learning.
- n) Actively promote the College core values throughout your role and working at the College. Participate in staff engagement opportunities to contribute to the College overall strategic objectives.
- o) Attend, relevant meetings, open events, college promotional events as may be appropriate.
- p) Maintain up to date knowledge of development within the education sector in relation to delivery of Maths to students.
- q) Actively participate in the College Performance and development process and the Teaching, Learning and Assessment process and continue to develop your own teaching practitioner skills. Complete all mandatory and other relevant training as directed within the time limits.
- r) Adhere to all College policies and procedures, including but not limited to safeguarding, GDPR, Equality, Diversity & Inclusion, Health & Safety. All College policies are available on the intranet and you will be advised of the ones relevant to your role.
- s) Undertake other responsibilities as directed by any member of Executive Board or the Leadership and Management Team.
